Halfway Home Pet Rescue, Inc. is not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities for the Rescue. Halfway Home Pet Rescue, Inc. does not carry volunteer insurance. Volunteers will need to provide their own insurance to the ER at the hospital in case of injury by an animal they might work with.
- 4. I understand and agree that the Rescue may refuse Volunteer Applications for any reason.
- 5. If I will be sheltering or providing foster care or boarding of any of the Rescue's animals in my home or business, I consent to the Rescue visiting my home or business from time to time to observe the animal(s) and their living quarters.
- 6. I have accurately and truthfully completed this Volunteer Application and Agreement.
- 7. Any modification to this Agreement must be in writing signed by both parties. This Agreement is binding upon the Rescue, myself, and the Rescue's and my respective heirs, successors, assigns, executors, and personal representatives.
